Types (Classes) of Membership

SHRM Members

Persons who are full members in the Society for Human Resource Management (SHRM) may become members of the Panhandle Human Resources Association (PHRA) upon request. The rights and privileges of SHRM members include the right to vote and hold office in the Association.

Annual dues for members in this class shall be \$35.00.

Regular Members

Persons currently employed in the practice of Human Resource Administration or faculty members holding assistant, associate or full professional rank in Human Resource Administration or any of its specialized phases in an accredited college or university shall be eligible for regular membership. The rights and privileges of regular members include the right to vote and hold office in the Association.

Annual dues for members in this class shall be \$50.00.

Student Members

Students of any accredited college or university who demonstrate to the satisfaction of the Executive committee a bona fide interest in Human Resource Administration and the purpose of the Association shall be eligible for student membership. Student members shall have no vote and may not hold office. There shall be no dues or assessments for the class membership.

Member Emeritus

Retired members of the Association shall be classified as Members Emeritus. Member Emeritus pays no dues and is welcome to attend any meeting as a guest.
